RECONVENE TO OPEN SESSION

President Wright reconvened the Special Board Meeting at 10:43p.m.

President Wright stated that the Board took action in Closed Session on Student C expulsion per Education Code 48900(c), 48900(d) & 48900(k). The student will be expelled from the Belmont-Redwood Shores School District until June 11, 2010, at which time the pupil may be reviewed for readmission to a school of this District. Pursuant to Section 48916(b), the Board recommended a plan of rehabilitation for the pupil, consisting of:

- Immediate enrollment in the District's Community School during the term of the Expulsion
- An independent study program to be provided by the District.
- Completion of all required studies in the alternative educational placement.
- Remaining drug-free during the term of the expulsion.
- Successful completion of a drug education program provided or recommended by the District.
- 10 hours of community services as agreed upon between the student and staff.

The expulsion was then suspended and the student ordered to return to school.

President Wright stated that the Board took action in Closed Session on Student B expulsion per Education Code 48900(c), 48900(d) & 48900(k). The student will be expelled from the Belmont-Redwood Shores School District until June 11, 2010, at which time the pupil may be reviewed for readmission to a school of this District. Pursuant to Section 48916(b), the Board recommended a plan of rehabilitation for the pupil during the expulsion, consisting of:

- Immediate enrollment in the District's Community School during the term of the Expulsion
- An independent study program to be provided by the District.
- Completion of all required studies in the alternative educational placement.
- Remaining drug-free during the term of the expulsion.
- Successful completion of a **drug/anger management/family/other** counseling program provided or recommended by the District as determined to be appropriate by staff.
