Superintendent's Letter

I have several important items to share with the school community in this issue of *School News*. To begin with, our budget picture is looking brighter. We originally forecasted a budget shortfall of \$600,000 to \$700,000 for the 2005-2006 school year, after Measure G passed in November 2004. A part of that projection was due to a proposed increase in our State Teachers Retirement System (STRS) contributions. The Governor's budget this year proposes to transfer the state's contribution to the school districts. For Belmont-Redwood Shores, this would add a \$237,000 cost to an already tight budget.

The good news is that we are fairly certain that this proposal will

be defeated on the floor of the Legislature. The other piece of good news is that we have gained approximately \$350,000 in one-time money for the general fund due to two significant actions: We refinanced our COP (Certificate of Participation), which is money we have borrowed through bonds for initial construction of Sandpi-

per; and we refinanced our General Obligation bond (GO), which is bond money we used to modernize our schools and to complete Phase 2 of Sandpiper.

The savings on the bond refinances, combined with projected STRS savings, help narrow the budget deficit. However, there is still more work to do on next year's budget. Even with the Measure G Parcel Tax funds and a \$300,000 School-Force contribution, we still need to maintain a tighter staffing allotment at our school sites and watch our revenue and expenditure flow carefully to get to a balanced budget.

Many of you have contacted me

Electronic Arts Learning Center Opens for Business

The Electronic Arts Community Learning Center (CLC) opened on January 15 and is doing a brisk business. Housed in a completely renovated building at the back of Nesbit Elementary School, the CLC is outfitted with blonde wood tables and chairs and poster-sized photos of kids using the lab's new equipment. The room is sleek and uncluttered, but it actually is packed with some of the most powerful educational technology

available. The equipment includes five networked PCs, printers, scanners, networking hardware, an interactive whiteboard, a data projector, digital video cameras, digital cameras, and (the heart of the lab) three mobile carts that each hold 15 wireless laptop computers, as well as two large duffel bags that each hold 7 wireless laptops.

The CLC—funded largely by Electronic Arts, as well as with donations from Oracle and the Peninsula Com-

munity Foundation—was created to enhance the teaching and learning experience in the District. Last summer, 90 percent of the Nesbit staff and at least one teacher from each school in the District came to the CLC to learn how to use the available technology. These teachers also attend staff development trainings once a month to help them share what they've learned with the other teachers at

with questions regarding the School Board’s recent resolution to the enrollment issue at Sandpiper Elementary. In this letter, I’ll outline the Board’s plan; on the insert in this newsletter, I’ll answer specific questions that you might have about the plan.

The enrollment plan includes the following items:

- A Prop. 39 School Facilities Improvement District Bond Measure will be placed on the ballot for Redwood Shores/Belmont Shores to construct a new school that will accommodate the 900 elementary students that will be residing in Redwood Shores by 2009.
- For the 2005-2006 school year, all Redwood Shores/Belmont Shores kindergartners will attend Nesbit Elementary, while those in grades 1 through 5 will attend Sandpiper.
- For the 2006-2007 school year, all Redwood Shores/Belmont Shores kindergartners and 1st graders will attend Nesbit, while those in grades 2 through 5 will attend Sandpiper.
- For the 2007-2008 school year, the process will continue.
- When a site is located and the bond has passed, the Board will draw the attendance area boundaries to fit the new school.
- If a site is not located or the

bond does not pass, the boundaries will be redrawn in advance of the 2009-2010 enrollment period.

I would like to acknowledge and thank the Board for its hard work on this issue. Each board member put an incredible amount of time and energy into the process, while keeping sight of three primary objectives: to create an enrollment plan that would reflect the District Mission and Core Principles, work toward the best interests of all students in the District, and use district resources effectively and efficiently. It was not an easy job.

I would also like to thank the participants in the enrollment study sessions. They took on the difficult task of identifying fair and workable solutions to the overcrowding issue at Sandpiper and coming to a consensus on the options. Their work was an important part of the Board’s overall effort.

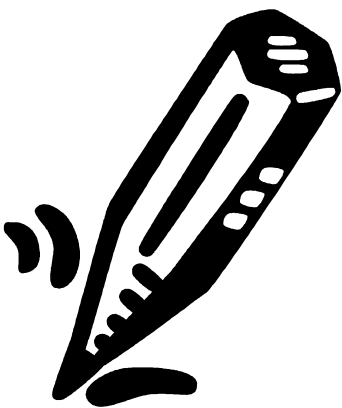
Over the past year, the Board and the entire school community have faced some very difficult issues from budget shortfalls to burgeoning enrollment at Sandpiper. In order to achieve success in addressing these issues, the solutions we choose and implement must incorporate the involvement of parents, staff, and others who live in our community.

I encourage you to attend and to participate in the upcoming 2005-2006 budget development meetings. On February 17, school staff and parents from each school participated in a board study ses-

sion on the budget and made recommendations to the Board. The budget development process will be addressed at regularly scheduled board meetings with a final adoption of the 2005-2006 budget anticipated at the June 16 board meeting.

In addition to these and regularly scheduled board meetings, the District will be holding three community forums. These forums were designed as a way for the school community to interact with the Board on issues that are important to them. The first forum—which included the Sandpiper and Nesbit communities, as well as district staff, and board members Cathy Wright and M.J. Crousore—was held February 16. The second forum—with those from Central, Cipriani, and Fox, district staff, and board members Eric Shrader and Karen Clancy—will meet Wednesday, March 2, at 7 p.m. in the Cipriani Multi-Use Room. The open forum at Ralston will be held Wednesday, March 9, at 7 p.m. Please plan to attend these meetings and to share your ideas and concerns with us.

Finally, I would like to express my gratitude and appreciation for the staff, parents, and community members who worked so hard to pass Measure G. With their help, and with the ongoing input and participation of our school community, we can continue to provide the programs and services that are essential to providing our children a high-quality education.—John McIntosh



Board Notes

Hello. As your new board president, I would personally like to invite you to an upcoming school board meeting. You will see representative democracy in action and can gain insights for yourself into how your board is thinking on the issues. Sometimes, as has been the case recently during our discussion regarding proposed solutions for the district enrollment issue, we have a full house, with many people engaged in the process. Much of the time, though, we have very few folks in attendance.

At each board meeting, we are making decisions that will affect all of our students and the community at large. I encourage you to keep an eye on our agenda for items that interest you and to attend a meeting or two to get a feel for how we do business. The

process will then be more familiar to you if an item arises that you feel passionate about.

Many people, during my three years on the Board have said things like: "I didn't know you have been discussing this issue," or "Why wasn't I asked for my input?" and "When did you make that decision?" We are your board, we discuss almost everything in public, and you are invited at each meeting to provide us input on district business. In 343 BC, Aristotle said, "If liberty and equality, as is thought by some, are chiefly to be found in democracy, they will be best attained when all persons alike share in the government to the utmost."

These words are as true today as they were then. Your board needs you to share in the governance of

your district, by providing your input on the issues facing us all, by listening to our deliberations and thought processes, and by helping us communicate with the greater community.

We believe that the parents in our district want the very best education for their children, and we as a board want to provide the support for our professional staff and our wonderful teachers to make that happen.

Our role in this is not really to run the district—that is our staff's responsibility—but rather to make sure that the District is well run. In order to do that effectively, we need input from everyone involved. Again I personally invite you to come and participate in that process.—Eric Shrader

their schools.

Jeanine Woodell, the director of the CDC, shares some ways teachers are using this new equipment at Nesbit:

"A 5th grade teacher had her students present their autobiographies, complete with digital photos, using PowerPoint presentations," she says. "The kids loved it.

"A 2nd grade teacher used the interactive whiteboard to teach a unit on money. Using the whiteboard's special pen, students gathered nickels, dimes, and quarters from the screen to make stacks of

coins that each represented one dollar."

In addition, the center is open to students before and after school. Mrs. Woodell and volunteer high school students from the San Carlos Charter School staff the center in the morning to offer homework support to Nesbit students. Nesbit parents help staff the after-school homework center. "In the morning there are usually 15 kids in here," says Mrs. Woodell. "After school, there are 20 to 25 students."

The Community Learning Center was made possible with a gener-

ous grant from Electronic Arts. In addition, Oracle, Corp., is funding the director position at the CLC; and The Peninsula Community Foundation has provided a planning grant and may provide ongoing funding.

In March, the CLC Leadership team will meet to plan the implementation of Phase II. The goals of Phase II include providing community access to the center, making it a resource for parents, hiring a bilingual afternoon coordinator, and recruiting volunteers for one-on-one tutoring. —Jill Aldrich

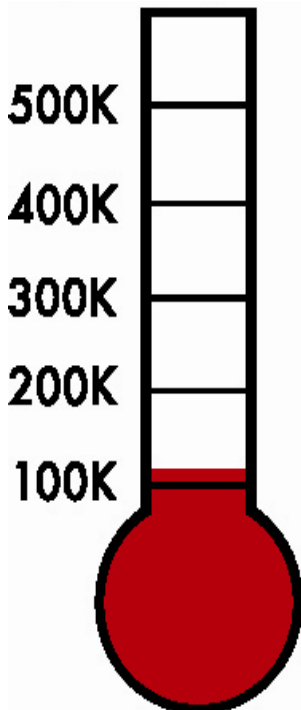
